POINTS OF GRACE stalked the pace, closed on the turn, chased four-wide into the stretch, bid midstretch and drove clear then held under steady pressure. LOMAKI, in range midpack, was hustled into the stretch, rallied between foes and was gaining steadily. SHERATON PARK sprinted clear, moved to the rail and set the pace, was collared midstretch and gave way grudgingly. DANCE TO MY TUNE, in range, chased five-wide into the stretch, herded a rival inwards from midstretch then evened out late. AVIE'S TALE, in range three-wide, chased into the stretch, was herded from midstretch and evened out late. YOU WILL LOVE ME, in touch, saved ground, was hustled into the stretch but never threatened. SAN NICOLA WHISKEY raced midpack in hand, quickened late turn, came five-wide to the top of the stretch but never reached contention. HELLO MAGGIE MAY, in range, chased three-wide into the stretch, was under an all out drive but flattened out late. RING BLING, rated early, saved ground, was hustled into the stretch but never reached contention. A CLAIM OF FOUL BY THE RIDER ON AVIE'S TALE AGAINST DANCE TO MY TUNE FOR INTERFERENCE IN THE STRETCH WAS DISALLOWED.
